In pursuance of the above references, the following modifications were made to Academic Information and Regulations No. 12.2.1,13.3 and 14.1 of the Post Graduate degree programmes 2022-23. The modifications details are as below:

12.2.1 There shall be an Advisory Committee for every student consisting of not fewer than three members in the case of a candidate for Masters' degree and four in the case of Ph.D. degree in addition to the Major Advisor. The Advisory Committee should have minimum of two members from the major field and one member from minor field amongst the members of the Post-graduate faculty.	12.2.1 There shall be an Advisory Committee for every student consisting of not fewer than three members in the case of a candidate for Masters' degree and four in the case of Ph.D. degree in addition to the Major Advisor. The Advisory Committee should have minimum of two members from the major field amongst the members of the Post-graduate faculty. Proposal for constitution of Advisory Committee shall be submitted in Form No – 1 in AMS. Change of the Major Advisor or Co-Advisor or any member of Advisory Committee is not ordinarily permissible. However, in exceptional cases, change may be submitted in Revised Form No – 1 for getting approval of the Dean (PGS) and Director of Education.
13.3 The Plan of work in the prescribed form shall be sent to the Dean (PGS) through the Head of the Department and Dean of the respective College by the end of the first semester for approval.	13.3 The Plan of work in the prescribed form shall be sent to the Dean (PGS) through the Head of the Department and Dean of the respective College by the end of the first semester for approval. Plan of Work shall be submitted in Form No – 2 in AMS for the approval of Dean (PGS). Under extraordinary situations if revision of Plan of Work required, Revised Form No – 2 need to be submitted for the approval of Dean (PGS)

14.1 The programme of research of the students in the prescribed form as proposed by the Advisory Committee shall be sent for approval of the Dean (PGS) through the concerned Head of the Department and Dean of the College by the end of the 12th week of the Second Semester of first year Degree programme

14.1 The programme of research of the students in the prescribed form as proposed by the Advisory Committee shall be sent for approval of the Dean (PGS) through the concerned Head of the Department and Dean of the College by the end of the 12th week of the Second Semester of first year Degree programme. **Programme of Research shall be submitted in Form No – 3 in AMS for the approval of Dean (PGS). If there is partly change in the existing research topic at any stage of research, Revised Programme of Research in Revised Form No – 3 need to be submitted by the student. If there is change of crop or complete change of research topic after completion of certain research credits, previously completed research credits will get cancelled and the student has to submit the Revised Plan of Work in Revised Form No – 2 and Revised Programme of Research in Revised Form No – 3**

The above modifications shall come into force with immediate effect.
