## Note:


- All students should compulsorily submit the **registration card in AMS with approval** of Course teachers, Counsellor, Assistant Comptroller, Warden, Librarian on or before **23.04.2025**.
- All students are here by informed to pay semester fees through **SBI Collect** only, upload fee receipt in AMS. if any wrong payment has been done you are held responsible.
- **Student Feedback** submission in AMS is compulsory (AMS is not allowed to submit registration card unless previous semester feedback form is submitted. (I B.Sc(Hons)Horticulture, I Sem)
- The SC/ST fee structure is formulated in accordance with guidelines for Post matric scholarship to the students belonging to scheduled castes for studies in India (2020-21 to 2025-26), March 2021.
- \*The SC/ST students whose parental income is Rs. 0 to 2.5 Lakhs per annum need not pay any fees at the time of sem registration except convocation fees. However, they have to provide an undertaking to return the amount reimbursed by the Social Welfare Department to the respective University/Colleges. After the admission, these students have to apply through online / upload their application with required documents to the District Officer, Social Welfare Department for reimbursement as indicated with \* symbol in the fee structure. However, reimbursement amount will be credited directly to the students account by the Social Welfare Department.
- The SC/ST students whose parental income is Rs. 2.5 to 10.00 Lakhs per annum have to pay the fees 50% of total fees except convocation fees and the remaining 50% of total fees will be met out by the concerned Universities from SCSP and TSP Grants(Subject to allocation of budget from the Government to the Farm Universities). After the admission, these students have to apply through online / upload their application with required documents to the District Officer, Social Welfare Department for reimbursement as indicated in the fee structure with \* symbol. However, reimbursement amount will be credited directly to the students account by the Social Welfare Department.
- The SC/ST students whose parental income is Rs. 10.00 Lakhs and above per annum have to pay the GM fees as General Merit candidates at the time of sem registration.
- **The SC/ST students of Karnataka State admitted under ICAR quota have to pay the prescribed fees as applicable to State quota SC/ST students.**
- \*\*Cat-I and OBC students have to pay the prescribed fees at the time of sem registration as mentioned in the Sl. No 21. After the sem registration, these students have to apply through online/ upload their application with required documents to the District Officer, Backward classes Welfare Department for reimbursement as indicated in the fee structure with \*\* symbol, However, reimbursement amount will be credited directly to the concerned students account by the concerned Department.
- If any fee is not reimbursed by the Social Welfare Department or Backward Classes Welfare Department or SCSP/TSP grants from the University, students concerned have to pay the fees before the issue of their PDC/OGPA.
- During their study period if any breakage/ damages are done by the individual students, then they invariable have to pay their dues to the concerned college before the issue of their PDC/ OGPA.
