As per the Regulations no. 16.2 and 16.3 of the Post Graduate Academic Information and Regulations (AIR):2022-23, the advisory committee has to conduct the final *viva voce* examination of the thesis of Post graduate students within one month from the date of receipt of the evaluated thesis and its report. Further, if not, under extraordinary circumstances with the prior permission from the Dean (Postgraduate Studies), the student is allowed to complete final *viva voce* within six months of receipt of evaluated thesis and report on payment of prescribed penal fee of Rs. 500/-.

In some cases, the post graduate students could not complete within the above said maximum period they shall be imposed higher penalty of Rs. 5000/- for delay in conduct of the final thesis *viva voce* examination, with prior permission from the Dean (PGS) based on justifiable reasons after six months and within the stipulated maximum period for completion of degree programme as per the Post Graduate degree programmes Academic Information and Regulations.

This notification come into effect immediately and also applicable to all the students who are onroll.
